MECHANICAL, ELECTRICAL, PLUMBING, RE-ROOF, FENCE, DRIVEWAY, DEMOLITION, MISCELLANEOUS

Before **any** development activity occurs on a piece of property, a permit is required from the local jurisdiction. A permit is required before carrying out any building activity, the making of any material change in the use or change in appearance of any structure.

Contractors applying for a building permits must submit a current copy of the following items: Town of Redington Beach Business Tax Receipt Pinellas County Contractor Licensing Board (PCCLB) Competency Card or Registration State License (if applicable) Certificate of Insurance for General Liability & Workers' Compensation (or Workers' Compensation Exemption Certificate).
